**Easy "Treat" before you start Your 2009 diet!**

### INGREDIENTS (Nutrition)

- \* 1 (10 ounce) package saltine crackers
- \* 1 cup butter
- \* 1 cup light brown sugar
- \* 1 (12 ounce) package semisweet chocolate chips
- \* 1 cup slivered almonds

### DIRECTIONS

1. Preheat oven to 325 degrees F (165 degrees C). Grease a baking sheet. Line baking sheet with saltine crackers, edges touching.

2. In a medium saucepan, combine butter and brown sugar and cook until mixture reaches 235 degrees F (112 degrees C) or a small amount of mixture dropped into cold water forms a small ball that flattens when placed on a flat surface. Pour mixture over crackers and spread evenly.

3. Bake in preheated oven 15 minutes. Sprinkle chocolate chips over hot toffee. When chips turn glossy, spread evenly with spatula. Sprinkle with almonds. Freeze 20 minutes before serving.

Those of you who got my last post on our Yahoo group page may have noticed the disconnect between the title and the information about Bluebird Yarn and Fiber Crafts in Sausalito in the body. I titled the post "Back-Stabbing in the Knitting World," decided not to talk about that, and hit "Send" before I remembered to change the title! Something that has happened to us all, right? What I started to do, and decided to save for this newsletter, was report that Sophia Kurnik, the owner of Bluebird, went to various yarn stores introducing herself before she started her new business. She included Atelier Marin in her round of visits. After she left there, Atelier's owner, Amanda, called the yarn distributors to tell them not to sell yarns to Sophia! This to me is the opposite of the spirit of knitting, and provides further evidence that

the spirit of sharing, and mutual support and of inclusivity is not present at Atelier in San Anselmo. I have boycotted that store personally after they refused display our brochures, and have urged other knitters to do the same.
